

NOTICE INVITING TENDER

Sealed offers are invited by Rajkot Municipal Corporation in **Single Stage Two Bid Cover System** for **Revitalization of Shri Arwind Maniar Hall** at Jubilee Garden, Rajkot, from competent, qualified and experienced bidders. The estimated cost of the work is Rupees Eighty Lacs and the time limit for completion of the work is Eight Months.

The work comprises of Civil Interior & Acoustic Work, with specialized services including Electrical Work and Mechanical Ventilation System.

Tender documents in 4 Volumes containing Pre-qualification Requirements, Tender Conditions including Joint Venture Conditions, Specifications, Bid Documents and Drawings will be made available from the office of the Executive Engineer, Rajkot Municipal Corporation, Dr Ambedkar Bhavan, Shri Dhebarbhai Road, Rajkot, on payment of Rs 2200.00 (Rupees Two Thousand Two Hundred Only) during working hours from Monday, 03-04-2006 to Tuesday, 10-04-2006, upto 1300 hours. If tenders are demanded by post, extra amount of Rs. 300.00 shall have to be paid against the postal charges.

The Bidder should satisfy the following Qualifying Criteria:

- i) Financial Criteria:
- (1) An average annual turnover of last three year should not be less than INR. 9.60 Million. (Appendix-C)
 - (2) Working capital (to be demonstrated by the bidder in the form of confirmed credit line from reputable bank or the bidder's own audited financial statement taking into account current commitment): INR. 2.0 Million. (Appendix-Q)
 - (3) Net Cash Accruals should not less than INR.1.20 Million. Net Cash Accruals shall be determined as the sum of profit after tax and depreciation in that year. (Appendix-C).

- (4) An average Net worth of last three years should not less than INR. 1.60 Million. Net worth shall be determined as the sum of the equity capital and free reserves.
- (5) Bidder shall be a Government Registered Contractor registered in appropriate class

ii) Experience Criteria:

The bidder should possess following minimum experience

- (1) An experience of constructing housing complex / auditorium / town hall / community hall of minimum 3000m² - one number in single contract as a main agency
- (2) An experience of providing and erecting Air Cooling system minimum capacity of 10000CFM - one number in single contract as a main agency
- (3) An experience of providing and erecting Electrical and Mechanical work in similar place of public gathering - one number in single contract as a main agency
- (4) An experience of providing and erecting Interior work and Acoustical System in similar place of public gathering of minimum capacity 250 persons- one number in single contract as a main agency

Each bidder shall have to pay an EMD amounting to Rs.80,000.00 (Rupees Eighty Thousand Only) along with the Tender Documents. The EMD has to be paid in form of either DD in favor of RMC payable at Rajkot or Receipt of Cash deposited at RMC, along with the bid documents. Offer without EMD will be considered non-responsive.

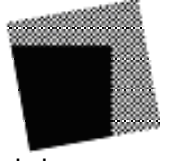
